STEAMBOAT SPRINGS AREA FIRE PROTECTION DISTRICT

A RESOLUTION CALLING FOR THE 2023 REGULAR DISTRICT ELECTION AND APPOINTING A DESIGNATED ELECTION OFFIFICAL

WHEREAS, the Steamboat Springs Area Fire Protection District ("*District*") is a political subdivision of the State of Colorado, organized pursuant to C.R.S. § 32-1-101, *et seq*. ("*Special District Act*");

WHEREAS, pursuant to C.R.S. § 1-13.5-111, the District is required to hold a regular election on the Tuesday succeeding the first Monday in May in the year 2023 to fill Director positions that have become vacant through expiration of the term of office or otherwise. Accordingly, the District is required to hold an election on May 2, 2023 ("*Election*");

WHEREAS, during the Election, three (3) eligible individuals must be elected to fill the positions currently held by Directors Miller, Hannaway and Allen, which elected individuals will then serve for a term of four (4) years each;

WHEREAS, pursuant to C.R.S. §§ 1-13.5-108 and 32-1-804(2), the District's Board of Directors ("*Board*") is required to name a Designated Election Official ("*DEO*") who is responsible for conducting the Election in accordance with the Colorado Local Government Election Code, the Special District Act, and all other applicable laws, rules, and regulations (collectively, "*Applicable Law*");

WHEREAS, after consideration it was determined that in the best interest of the District's electors, the District will hold the election as a mail ballot election; and

WHEREAS, it is necessary to set forth certain procedures concerning the conduct of the Election.

NOW, THEREFORE, be it resolved by the Board of Directors of the Steamboat Springs Area Fire Protection District that:

- 1. A regular mail ballot election of the eligible electors of the District shall be held on May 2, 2023, between the hours of 7:00 a.m. and 7:00 p.m. pursuant to and in accordance with all Applicable Law. At that time, three (3) Directors will be elected to serve a four-year term each. The election will be conducted by mail ballot. All mail ballots shall be returned to the Designated Election Official's office, located at 7995 E. Prentice Ave. Suite 103E Greenwood Village, CO 80111-2710.
- 2. The Board of Directors hereby designates Sue Blair, Community Resource Services of Colorado, as the Designated Election Official (DEO) for the conduct of the Election. The DEO shall have full authority to take any and all actions necessary and appropriate to

conduct the Election in accordance with the requirements of Applicable Law, including, but not limited to publishing a Call for Nominations, appointing election judges as necessary, appointing the Canvass Board, arrange for the required notices of election, printing of ballots, and direct that all other appropriate actions be accomplished.

- 3. Self-nomination and acceptance forms shall be available from the Designated Election Official via email sblair@crsofcolorado.com to or phone at 970-669-3611. All candidates must file self-nomination and acceptance forms with the DEO no earlier than January 1, 2023, nor later than the close of business on Friday, February 24, 2023.
- 4. If the only matter before the electors is the election of Directors of the District and if, at the close of business on February 27, 2023, there are not more candidates than offices to be filled at the Election, including candidates timely filing affidavits of intent to be a write-in candidate then the Designated Election Official shall cancel the Election and declare the candidates elected by acclamation. Notice of such cancellation shall be published and posted in accordance with the requirements of Applicable Law.
- 5. The District shall be responsible for the payment of any and all costs associated with the conduct of the Election, including its cancellation, if necessary.
- 6. If any section, paragraph, clause, or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining provisions of this Resolution.
 - 7. The provisions of this Resolution shall take effect immediately.
